  - REFINANCE THROUGH ANOTHER PARTY
  - FULL OR REDUCED PAYOFF
  - SALE TO A THIRD PARTY

## LEGAL - LOCAL COUNSEL

- SEND A NOTICE OF DEFAULT/TERMINATION OF CONTRACT
- FILE COMPLAINT AND ATTEMPT TO SERVE DEFENDANT WITH NOTICE OF COMPLAINT
- SCHEDULE HEARING WITH COURT
- APPEAR AT HEARING
- EXECUTE WRIT OF EVICTION AND SCHEDULE SET OUT DATE
- MOVE VENDEES FROM THE PROPERTY AND SECURE IT

  - VENDEE INDISPOSED OUT OF THE COUNTRY OR IN JAIL
  - REQUIRED TO PUBLISH NOTICE IN NEWSPAPER
  - SQUATTERS

- HEARINGS
  - HIGH NUMBER OF CASES PENDING BEFORE THE COURT
- COUNTERCLAIM BY VENDEE
- EVICTION REQUIRED IF VENDEE DOES NOT VACATE THE PROPERTY
